

Chicago Lawyer Thomas Demetrio Interviewed by Korean Media about Asiana Plane Crash Lawsuits

CHICAGO, IL, USA, July 25, 2013 /EINPresswire.com/ -- <u>Corboy & Demetrio</u> attorney Thomas Demetrio spoke about possible venues, including Chicago, for potential litigation against Boeing stemming from the crash of Asiana Flight 214 in his interview with The Korea Times newspaper.

Demetrio, who has represented plane crash victims for more than 30 years, says lawsuits filed by passengers in the crash of Asiana Flight 214, can be filed in their home countries, the final points of their destinations, California or Chicago.

In his Korea Times interview, Demetrio explained that the National Transportation Safety Board (NTSB) is interested in "safety of the air-travelling public" and does not have any interest in protecting air traffic controllers.
