\*With the Queen's blessing, Mr. Coates, a shipbuilder, undertook a project to build a replica of the Britannia using some of its original pieces. Unfortunately, financial distress caused a standstill until it was purchased in late 2011 by K1 Britannia

-The Britannia's deck can comfortably hosts up to 250 people, creating a floating venue for gala events, fundraisers, and charitable activities around the world

-Britannia Trust expects to gift the use of the vessel to a minimum of 75 charity parties a year across numerous cities around the world

\*To complete Britannia's build, Britannia Trust is seeking approximately £6 million, largely from corporate sponsors

-Britannia Trust will partner with at least six corporate sponsors, each being the sole representative in their category

-Each corporate sponsor will be required to commit to starting with £1 million upfront to cover the cost of the build and £250,000 a year with a 5, 7, or 10 year commitment to cover annual running expenses

\*The Britannia Trust team looks forward to discussing interest in restoring a legendary ship while helping charities throughout the world
