Savanna Filip's awards include the \$200 prize for the Best of Show and she won First

Special Categories created by the Judges went to Dennis Pesek for Exuberant Impressionism, an oil painting of the Lavaca County Courthouse designed by Eugene Heiner. Also, a Family Heritage Documentation award was given to Doris and

Bob Zumwalt for their historic home in Hallettsville, Texas.

The contest was in conjunction with a two-day conference: 3rd Annual Hallet Oak Gallery "Art in Architecture" Celebrating Victorian Design -- which encompasses the reign of Queen Victoria (1837 – 1901). All entries had to depict some aspect of Victorian design. The Texas Society of Architects

co-sponsored the event. Judges of the contest were Ann McGlone, AIA, President of Preservation Texas and Mike McGone, AIA, President of Texas Society of Architects.
