"Confusion persists about the role and use of patents, copyrighted content, such as music, and other IP rights. IPAS 2018 will explore ways to identify how best to provide audiences a context for understanding."

Confusion about the purpose, use and patentability of

inventions, authored works and designs, and their rights, has led to widespread IP theft on the part of both individuals and businesses. Uncertainty inhibits innovation and competition, increases frustration and discourages investment. IPAS 2018 will examine ways to improve audiences' basic IP awareness.

Registration is free except for a nominal charge for overhead and is now open for the second annual Intellectual Property Awareness Summit – IP Literacy in a Digital World. The Summit will examine the impact of information and speed on how intellectual property is seen and often taken for granted, as well as ways to address it through education and the media.
