Hernias occur when an organ (or fatty tissue) pushes through the muscles that keep them in place. Thus, pain is common and doctor's visits are critical. Doctors perform various repairs to fix the hernia.

However, complications resulting from hernia mesh surgery are now so common that the U.S. Food and Drug Administration (FDA) has issued multiple public <u>safety</u>

<u>notices</u> and investigations about the risks that hernia mesh products may cause.

Common injuries reported to the Administration include punctured intestines, abdominal tears, severe pelvic pain, infection, recurrence, adhesion, obstruction, and perforation. As a result, those suffering from a defective hernia mesh may need to undergo further surgical procedures to fix what went wrong. If so, a patient would need to take additional time off work and face additional medical expenses, medication and follow-up treatments.
