What does matter is a person like this talks to a lawyer who knows what they are talking about when it comes to compensation for a person like this. High-risk work groups for exposure to asbestos in West Virginia include US Navy Veterans, power plant workers, maritime workers along the Ohio River, oil refinery workers, steel mill workers, coal miners, manufacturing, or industrial workers, public utility workers, plumbers, welders, insulators, millwrights, pipefitters, electricians, auto mechanics, machinists, or construction workers. Typically the exposure to asbestos occurred in the 1950's, 1960's, 1970's, or 1980's. <u>www.karstvonoiste.com/</u>

According to the American Cancer Society for nonsmokers who have been exposed to asbestos in their workplace the risk of lung cancer is five times that of unexposed workers.


