promptly. Adrenaline may temporarily mask pain, and delayed care can weaken the link between the accident and resulting health issues. From a legal standpoint, timely medical records are crucial in substantiating injury claims.

Holliday also highlights the need for measured communication. Riders should notify their insurer but refrain from discussing fault or providing speculative details until all facts are clear. Speaking with an attorney experienced in motorcycle cases can ensure that insurance interactions are handled properly and that the injured party's rights are protected.
